C. Remove Sue Osborne as Key Executive and retain Jan McKenzie as Key Executive on the Wells Fargo account

Wells Fargo requires at least one person to be named as "Key Executive", which makes them responsible for the bank account. They must be present in a branch to make any changes to the account.

Sue Osborne was Key Executive during her time as Treasurer. Sue and Jan (new Treasurer) went to a Wells Fargo branch together and added Jan - so we now have 2 Key Executives: Sue and Jan. This means they both have to appear in a branch together to make any changes. This is not ideal for Jan, as she lives in Fort Collins and Sue lives in Highlands Ranch. Additionally, Sue is no longer on the Board.

Vice Chairman McCune motioned to remove Sue Osborne as Key Executive and retain Jan McKenzie as Key Executive on the Wells Fargo account. Director Yorga seconded the motion, motion passed.

D. Close the Colorado Chapter of 99s Bellco Credit Union account

There are CDs invested at Bellco Credit Union, using funds from the Ruehle Award scholarship money. The account was opened by Sue Osborne, Jane Link, and Bev Sinclair, at the time when Sue was Treasurer and Jane and Bev were members of the scholarship committee.

Sue Osborne and Jan McKenzie (new Treasurer) went to Bellco to add Jan's name to the account and inquire about cashing out the CDs. They were told that the only time account actions can be taken is within 10 days of the CD maturity date, which is March 1st. This situation is not ideal and presents a few challenges. Bellco informed them that they may cash out the CDs early by taking a board vote, recording some specific language in the minutes, and getting a signed letter stating the request.

The Chapter Scholarship Committee met June 5th and decided to cash out the CDs at Bellco Credit Union early, and to deposit that money into the Wells Fargo checking account. The committee requested assistance from the Board with a vote.

Vice Chairman McCune motioned to close the account, and request the funds be made into a check made out to the Colorado Chapter of 99s. Director Yorga seconded the motion, motion passed.

## E. Fundraising for the chapters general fund

Chairman Willson asked for the members to come to the next meeting with ideas on how the chapter can raise money for the general fund. Professional headshots in collaboration with an event could be a possible fundraiser.
