2023 RUEHLE ADVANCED RATING AWARD INSTRUCTIONS

Eligibility Requirements — Each applicant must:

- 1. Applicant must be female, reside in and undergo flight instruction in Colorado.
- 2. Applicant must hold a minimum of a FAA Certified Private Pilot.
- 3. Applicant must be applying for an FAA Advanced Rating, i.e., Commercial, IFR, CFI, Multi-engine, Glider, Lighter-Than-Air, ATP, etc.
- 4. Applicant must demonstrate financial need for Award.
- 5. Applicant must have a current, valid FAA Medical Certificate appropriate for the pilot certificate being sought.
- 6. Applicant must have logged a minimum of five hours in the six months immediately preceding the application submission deadline. The flight time may be PIC, SIC or dual instruction. Submit a copy of the logbook pages showing the most recent 20 flights.

Application Deadline – Must be received by **July 31, 2023**.

<u>Complete Application Packet</u> – Each application must include:

- 1. Completed application (CLICK HERE)
- 2. Copies of the following:
 - Pilot certificate (both sides), if required for the certificate being sought, and driver's license (both sides)
 - **Logbook entries** documenting minimum of five hours in the six months preceding the submission deadline.
- 3. Letter from applicant describing her **financial need and aviation goals** (less than 200 words)
- 4. Letter of **recommendation from flight instructor** (less than 100 words)

Notification — All applicants are notified via email and/or phone by August 15, 2023

- . <u>Award</u> The winning applicant(s) receives:
 - \$5,000 to be used toward flight training


